 Recycle is **Monday only** between 7:00 AM and 5:00 PM.  
 Rollaway carts and recycle bins are provided by Republic Services (210)304-2787  
 Holidays (**no pick up**) Christmas Day, New Years Day, Thanksgiving Day, and 4th July

## BILLING:

The above services are **billed monthly** on one bill.  
**The bills are mailed the last week of the month.**  
**Bills are due on or before the 15th of the following month.** Bills not paid by the due date will incur a **10% late charge**. Bills not paid by the **25th will be disconnected**. A **\$30.00 fee** will be due before water is restored. ( Due once the non-payment list leaves the office). If restored after normal business hours an additional **\$20.00 after hours re-connect fee** will be due.
