**Request for Driving Safety Course:**

**You are eligible to request the Driving Safety Course Option by mail if all of the following are true:**

- ✓ You are at least 18 years of age.
- ✓ You have current liability insurance *and* a valid Texas Driver's License.
- ✓ You have *not* taken a Driving Safety Course within the last 12 months to dispose of a citation. (Calculated from the date of the last course completion to the date of your current citation.)
- ✓ You do not possess a Commercial Driver's License currently or at the time of offense.
- ✓ You are *not* charged with speeding in excess of 24 mph over the limit, nor a construction zone violation.

**To Request By Mail-**Provide the following three (3) items to Municipal Court:

1. Required Fee: Regular (*non-school*) Zone Violations \$109.10  
School Zone Violations \$134.10
2. Proof of valid Texas driver's license.
3. Proof of current insurance policy listing you as a driver.
