
2. Discussion/Possible Action on the appointment of Assistant Municipal Court Prosecutor with a term expiring June 30, 2022.

Mayor Pro Tem Kevin Hadas made a motion to appoint Mr. Joshua Galicia to serve as an Assistant Municipal Court Prosecutor with a term expiring June 30, 2022. Councilwoman Becky Harris seconded the motion. All Members present voted in favor of the motion.

3. Presentation by SAMCO Capital, the City's Financial Advisor, regarding a refunding of the City's outstanding Certificates of Obligation, Series 2012 for debt service savings and analysis regarding the possible issuance of tax notes for a fire engine, related apparatus equipment, and radios for first responders.

Andrew Friedman presented an opportunity for debt service savings based upon bonds that are callable this year. Mr. Friedman also described an analysis whereby the City could issue a tax note to fund a new fire engine, related-engine equipment, and new communication devices for Selma first responders. The presentation was for information only – no action was taken on this item.


